Operating Voltage:	9-32V DC

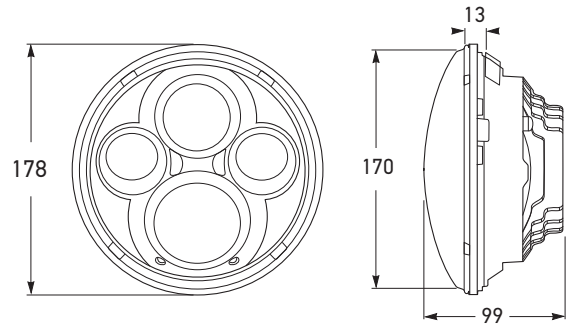

### Pre-Installation Guidelines

1. Read all safety notes and mounting guidelines before installing the product. Verify that all parts listed under "In the Box" are present and complete.
2. Inspect the product for damage. DO NOT install the product if there is any damage. Contact the authorized retailer where you purchased it to initiate a warranty claim if there is damage.
3. Verify that all power supply and/or charging systems comply to the specified voltage limits for the headlamp.

### Installation Instructions

1. Turn off the vehicle and disconnect the battery.
2. Remove the existing headlamps from the bumper. Be careful not to damage the bumper and keep all hardware that attaches the headlamp to the vehicle.
3. Unplug the connector of the existing headlamp.
4. Plug in the connector.
5. Lay and secure wires to avoid any pulling or abrasion that may damage the wires or headlamp.
6. Install the headlamp with the existing hardware into the bumper, with the HELLA logo oriented at the bottom.
7. Reconnect the battery and test that the headlamps are functioning correctly.
